Who we are and what we do?

We are the official body responsible for inspecting standards of care in Scotland. That means we regulate and inspect care services to make sure they meet the right standards.

We believe that everyone in Scotland should receive high quality, safe and compassionate care that reflects their rights, choices and individual needs through their whole care experience.

What are care services?

We regulate around 13,900 individual care services. The main types are:

- childminders
- care at home
- children's nurseries
- housing support
- playgroups and out of school clubs
- care homes for older people, adults and children

How can you get involved?

We believe that we can make care better by working with people who have personal experience of care services. Many of our inspections take place with inspection volunteers – people who work alongside our expert inspectors – who listen to the views of people using services and inform our findings. LGBTI and public services

We recognise that members of the LGBTI community may have a different experience of care compared to the wider population in Scotland. We have gathered a range of public statistics some of which you can read below.

33%

of LGBTI people would be uncomfortable being open about their sexual orientation or gender identity with adult social care staff.

89%

of respondents said LGBTI continue to face inequality in Scotland. Almost all LGBTI respondents (94%) said that more needs to be done to tackle prejudice and dscrimination against LGBTI people in Scotland.

LGBTI young people and trans young people in particular, often lack the confidence to report harassment and discrimination.

60%

of older gay people are not confident that social care and support services will be able to understand and meet their needs.

In light of this information, we will continue to work in partnership with organisations to improve the outcomes for the LGBTI community.
