



Looking after your care



The Scottish Social Services Council and the Care Inspectorate regulate social care services - and the people who work in them.

We are here to make sure that people receive the highest quality of care and that their rights are promoted and protected. Various kinds of organisations provide the services we regulate: local authorities, individuals, businesses, charities and voluntary organisations.

Who regulates social work and social care professionals?

Scottish Social Services Council (SSSC) regulates individual social workers, social work students and people who work in a range of different social services to make sure that you can have confidence that they are skilled, trained and able to do the job, including:



- care home services for adults
- adult day care services like day centres for people with learning disabilities
- residential care services for children and young people
- day care of children services
- housing support and care at home services.

We help to protect you by keeping a Register of the workers who must meet our standards set out in the SSSC Code of Practice for Social Service Workers, and have the right qualifications and skills for the job they do.

Most people will be registered with the SSSC however it is not yet compulsory for everyone working in social services. Some people may be registered with other regulators, for example, nurses may be registered with the Nursing and Midwifery Council. Where registration is compulsory, if someone isn't registered but is working, their employer will be breaking the law.

Who regulates social care and social work services?

The Care Inspectorate regulates and inspects social care, social work and child protection services in Scotland. We have a significant part to play in improving these services for adults and children. To see how good your service is, you can read the inspection report. A copy should always be available at your service, and you can ask to see it. Or, you can find it on our website **www.careinspectorate.com**

What standards can I expect from social services?

All individual social service workers must meet standards of practice and behaviour set out in the SSSC Code of Practice for Social Service Workers. All care services must meet the National Care Standards for the service they provide and they also have responsibilities as employers which are set out in the SSSC Code of Practice for Employers.

What should I do if I have concerns about a social service worker?

If you have concerns about the ability or behaviour of someone who works with and cares for you, your family or someone you care for you

should complain to the service that provided the care, for example a local authority, care home or nursery.

You may want to talk to the person themselves or to their manager or employer to see if they can put things right.

However, if that doesn't help or if you think what's happened is serious and questions the person's ability to do their job you can speak to the SSSC too. We can investigate complaints and, if necessary, we can remove a person from the Register which means they cannot work in social services.

What should I do if I have concerns about a regulated care service?

If you are dissatisfied with the level of care that you or someone that you know is receiving you have every right to question why something is going on and if the service is failing to meet the National Care Standards.

Who can make a complaint to the SSSC or Care Inspectorate?

Anyone can raise a concern or complain. Often the quickest way to resolve a complaint is by raising it directly with the provider. We would encourage this in the first instance wherever possible.

If you make a complaint, you can be sure that:

- complaints are taken seriously and handled thoroughly
- complaints are dealt with on an individual basis, and can be made anonymously

- we will decide how your complaint will be investigated, depending on what your complaint is about
- if we think there will be a delay, we will let you know and give you the reasons for the delay
- we always try to resolve complaints locally.
